COMPETITION FORMAT

Teams will be comprised of a maximum of three (3) players. Players must be separated by no more than 150 rating points at the time of entry (e.g., if the top player is 2000, the lowest rated player must be at least 1850).*

Prior to each round, teams will designate two (2) players to compete in the singles matches. The third team member may only play doubles (if necessary).

Team rounds will be played in the following format:

A-X B-Y B-X A-Y

If the teams are tied at 2 after the four singles matches, any of the three team members may play doubles.

Teams will compete in divisions of 8 teams (maximum of 96 team entries will be accepted), played in a Giant RR format.

Except the top-4 and bottom-4 seeded teams, all teams will play a qualification round on Saturday, October 8 at 9:00.

*The Tournament Committee may assign an estimated rating for an unrated player prior to the start of the event.

GENERAL POLICIES

All rostered players must compete in at least two (2) rounds. Defaults will not be counted towards the minimum participation. Teams not meeting the minimum participation requirement will be defaulted from all rounds and no eligible for prizes or awards.

All USATT regulations apply including dress code. No prizes awarded for splits, dumps, defaults, or no-shows. USATT approved tie-breaking procedures will be used.

Events may be modified at the discretion of the Tournament Committee. All decisions are final.

Ratings as of October 2, 2022 will be used for seeding.

ALL entry fees paid are non-refundable as of September 11, 2022. A \$50 administrative fee will be deducted from withdrawn entries before that date.

The Referee reserves the right to default a player not present at match start time for any event.

Entries not paid-in-full by the entry deadline will be removed from the draw. No exceptions.

Final entry deadline is October 2nd, 2022 (5:00pm PDT). The Tournament Committee reserves the right to accept late entries based on availability, however there will be a \$50 late entry fee.

All players must show proof of membership with USATT at the time of registration. Players not holding a current USATT membership must include their USATT registration or renewal fees along with their tournament event fees when submitting payment.

Teams may not change their player roster after 5:00pm on Sunday, October 2nd. The Tournament Committee may, in its sole discretion, permit changes in the event of injury or illness.
