1. AUTHORITY

The event will be hosted and organized by USA Table Tennis, under the auspices and authority of the Pan-American Table Tennis Confederation (ITTF-Americas) and International Table Tennis Federation (ITTF).

2. DATE

Preliminary Stage: Wednesday, 28 January 2026 to Thursday, 29 January 2026.

Should the minimum of 32 athletes per gender not be reached, the competition will be reduced by one day and will therefore commence on Thursday, 29 January.

Main Draw Friday, 30 January 2026 to 1 February 2026

QUALIFICATION ITTF Men's and Women's World Cup

Following the ITTF qualification system for the ITTF Men's and Women's World Cup 2026, the ITTF-Americas Cup San Francisco 2025 will qualify the top four players in each gender (with a maximum of 4 players per MA)

- Players are eligible for participation in Continental Events, as per

regulation 3.8 and 4.3.6 (ITTF Statutes).

13. ENTRIES

All entries must be submitted on the ITTF Entries Management System by providing all necessary information.

Players invited to play the main draw event through the <u>Qualification</u> <u>Pathway</u>, must confirm their participation via their member association through the <u>Event Management System</u> (EMS).

A cancellation fee of **USD 100** will be charged for each player cancelled after the final entry deadline without any justification.

For accompanying persons (doctors, physiotherapist, etc.) please contact the Organizing Committee to confirm the availability of places at the official hotel.

Each MA may enter:

Any number of players per gender for qualification stage and for main draw only the players invited through the <u>Qualification Pathway</u>.

No additional entry shall be allowed to enter after the final entry deadline, cancellations are accepted.

- **14. SPORT CANCELATTION** Substitutions for invited players before 28th Dec 2025 shall be as & CHANGES per entry regulation:
 - Players qualified in the continental Championships will be replaced by the next player with best result or the highest-ranked player based on the final standings of the event and according to the Pan American Ranking List current on Week 41, 2025.
 - Players qualified in the Regional Championships will be replaced by the next player with best result or the highest-ranked player based on the final standings of the event and according to the Pan American Ranking List current on Week 41, 2025.
 - Host Representative will be replaced by another representative nominated by the host.







- Players invited by ranking, will be replaced by the next highest ranked player on the reserve list, as per the Pan American Ranking List current on Week 43, 2025 (no more than two players from any association included the host).

Any substitutions occurring on or after 28 December 2025 shall be made using the next highest-ranked player from the Pan American Ranking (Week 43, 2025), respecting the limitation of a maximum of two players from the host association and a maximum of two players from any other association.



18. CANCELLATION POLICY

Accommodation cancellation after **5 JANUARY 2026 23:59** (UTC+0) will be required to pay **ONE NIGHT** of respective room rate.

Accommodation cancellation and/or 3 days before to start the competition, will be required to pay 100 % of respective room rate (full nights).

19. PAYMENTS

Payment should be made in USA currency upon arrival or by direct Bank Transfer upon receiving an invoice from the LOC.

Payment must be made by covering all bank fees, in connection with the bank transfers, after receiving the pro-forma invoice from the LOC.

The LOC will make hotel reservations and pick-up arrangements only for Member Associations which have completed payments.

22. DRAWS

The seeding and draw will be conducted based on the Table Tennis Ranking Week 5 , 2026 in all stages

23. TEAM MANAGERS.
MEETING & DRAW

The team managers meeting and draw for the main draw will take place on **29th January** 2026 (19:00 at the Venue).

24. MATCH OFFICIALS.

All matches will be officiated by qualified umpires in accordance with the Directives for Match Officials at World Title Competitions.

25. OBLIGATIONS

The entry will contain a statement that players nominated are willing to compete against any other participating player or team and that the participants respect and acknowledge regulations and rules on the ITTF Handbook. This statement must be confirmed by an official of the nominating Member Association, and no entry form will be accepted unless such an undertaking has been given.

26. LIABILITY

A. By entering the event, participants agree to abide by all ITTF rules And by the rules and regulations of the LOC. All entered associations, and players agree to be under the auspices of the ITTF and its agents in all matters concerning television coverage, video, internet web casting, motion picture coverage, and photographic coverage of any kind. Participants release all rights or rights held by their agents or sponsors, in all matters relating to television and web casting coverage, video and motion picture coverage, and photographic coverage of any kind; and hence accept such coverage during the event. A participant's refusal of above listed coverage January be subject to suspension or dismissal from the competition. Any participant, when called upon, must appear promptly to press conferences, or medal presentations and follow the procedures set by the ITTF, ITTF-Americas and the LOC.

B. By entering the event, each association must ensure that all delegation members confirm that they know that their personal data will be shared with the LOC, ITTF-Africa and ITTF who, in turn, undertake not to share it with any unauthorized person in any way.

C. In the context of betting, participants in the event shall follow the ITTF Code of Ethics (Chapter 6 of the ITTF Handbook). They shall not, by any manner whatsoever, infringe the principle of fair play, show unsporting conduct, or attempt to influence the course or result of a competition, or any part thereof, in a manner contrary to sporting ethics. Any violation of this principle shall be disciplined according to provisions of ITTF regulation 3.5.3.

D. By entering the event, all delegation members undertake to abide by the ITTF's anti-doping rules in effect (Chapter 5 of the ITTF Handbook).







E. By entering the event, all delegation members undertake to abide by the ITTF's anti-doping rules in effect (Chapter 5 of the ITTF Handbook).

F. By entering the event, all delegation members undertake to abide by the Code of Ethics and ITTF Anti-Harassment Policy and Procedures (Chapter 6 & 7 of the ITTF Handbook).
